#### ORDER:-

WHEREAS, approval was accorded for utilisation of vacant land measuring an extent of 063-88 Hectare that roughly works out to 1.5 acres, lying in the premises of Kanngi Govt. Girls Hr. Sec. School, Villianur for construction of two storeyed building for the existing Kasthurba College for Women vide of Order 1st read above.

- 2. AND WHEREAS, the Principal, Kasthurba College for Women, Villianur has stated that the land allotted for the construction of building for the college has been reassigned to the Labour and Welfare Department vide letter 2<sup>nd</sup> read above.
- 3. AND WHEREAS, the Director of School Education had submitted a proposal for transfer of the land measuring an extent of 1.80 Acres to the Directorate of Higher & Technical Education, Lawspet, Puducherry for the construction of Kasthurba College for Women, Villinaur, Puducherry vide 3<sup>rd</sup> read above.
- 4. NOW THEREFORE, in exercise of the powers conferred under rules 309 and 310 of the General Financial Rules, 2017, sanction of the Lieutenant-Governor, Puducherry is hereby accorded for the transfer of the land belonging to the School Education Department to the Directorate of Higher & Technical Education, Lawspet, Puducherry for the construction of College buildings for Kasthurbai College for Women on "NO PROFIT NO LOSS" basis as detailed below:-

- (ii) If the land is not utilized by the Directorate of Higher & Technical Education for the specific purpose for which the land is vested, the same has to be returned to the School Education Dept.
- (iii) There should not be any hindrance to the students or neighbouring public due to the proposed transfer of the land/construction work.
